## JUDGES & REFEREES APPLICATION REQUIREMENTS

Information and requisites for obtaining a Judge or Referee license in Arizona.

- **Arizona License Application** must be filled out **completely**. Email a Digital Photo of the Applicant to [info@azboxingandmma.gov](mailto:info@azboxingandmma.gov) and send in the License Application along with **CASHIER'S CHECK OR MONEY ORDER** in the amount of \$25.00, payable to the **Arizona Department of Gaming**. (*Personal Checks will not be accepted*). ***This application will serve as your registration with Arizona Boxing and MMA Commission:***
- **Copy of Driver's License, Valid Identification or other Lawful Presence Documents** must be provided along with Arizona License Application. (*Indicate on Page 2 of license application*)
- Fingerprints can be taken at a local Police Department, accompanied by a **CASHIER'S CHECK OR MONEY ORDER** in the amount of \$22.00, payable to the **Arizona Department of Gaming**. (*Personal checks will not be accepted*)
- **Read Arizona Boxing and MMA Commission Policy 06-022** and sign/date Standards of Conduct. (*Complete the Standards of Conduct on Page 2*)

**ALL requirements MUST accompany the application upon submittal.**

# ARIZONA BOXING AND MIXED MARTIAL ARTS COMMISSION

## STANDARDS OF CONDUCT

Referees/Judges and Officials, pursuant to Boxing Commission policy 06-022, shall abide by the following Standards of Conduct.

### Attire

1. Boxing Referees shall wear a black bow tie, a white or light blue colored shirt, black or dark blue slacks and black shoes.
2. MMA Referees shall wear a black polo shirt, black slacks and black shoes.
3. All other officials including inspectors shall wear a white or light blue shirt/blouse, a navy blue or black blazer or sport coat with slacks. Female officials may wear skirts.

### Performance

1. Referees and other Officials shall not drink any amount of any alcoholic beverage or any other substance that may impair their judgment prior to or during an event they are scheduled to officiate.
2. Referees and other Officials shall not eat while working a bout.
3. Referees and other Officials shall not visit one another while working a bout.
4. Referees and other Officials shall not criticize other officials, the Commission or members thereof.
5. Referees and other Officials shall not discuss official decisions or grant interviews to the media without consent from the Commission or its authorized representative.
6. Referees and other Officials shall not request to be assigned to a specific bout. Assignments are subject to the Commission and/or the Department discretion. All Officials must follow Commission and Department instructions and accept Commission and Department decisions.
7. Referees and other Officials shall not request free or discounted tickets from the promoter.
8. Referees and other Officials shall not request passes for spouses, relatives or friends.
9. Referees and other Officials shall not act or behave in such a manner as to: create or give the appearance of a conflict of interest; create or give the appearance of favoritism toward a contestant or any person having a relationship to a contestant; or reflect non-professional conduct.

I certify that I understand all requirements set forth in that policy and these Standards of Conduct and that I will abide by that policy and these Standards of Conduct at all times while licensed by the Arizona Boxing Commission. Additionally, I understand that failure to abide by that policy, by these Standards of Conduct or by any other Arizona Boxing Commission decision may result in disciplinary action up to and including suspension or revocation of my Arizona Boxing License.
