CONTESTANT – PROMOTER AGREEMENT

This Contestant-Promoter Agreement (the "Agreement") is effective as of the date of the last signature entered below, and is made between _____ (the "Promoter"), with offices located at _____; _____ (the "Contestant"), whose residence is located at _____; the Manager, if any, _____, whose business or residence is located at _____; and the Matchmaker, _____ whose business or residence is located at _____.

1. Contestant agrees to enter into a contest (the "Contest") for Promoter at _____ (the "Venue") in the City of _____, Arizona, on _____, 20___. The parties agree to the following conditions:

- a. There will be a total of ___ rounds in the Contest;
- b. Each round will have a duration of ___ minutes;
- c. The opponent's name is _____;
- d. Contestant and the opponent will compete at the weight of _____ (all non-title contests may have a variance of one pound), and is currently at the weight of _____;
- e. Contestant will be paid the sum of _____, and/or _____% of the gross receipts of the promotional event (the "Compensation"), and/or a bonus in the amount of _____, less state, federal, Commission taxes; other deductions are _____, and may only be deducted if approved by the Arizona Boxing and Mixed Martial Arts Commission (the "Commission");
- f. If Contestant has amateur status, he will not be paid Compensation;
- g. Promoter agrees to pay the following expenses, in addition to those statutorily-imposed fees that the Promoter is required to pay: _____
- h. Each signatory to this Agreement is duly authorized and licensed under the laws of the State of Arizona to conduct unarmed contests therein.

2. Contestant and Manager/Trainer, if any, certify and represent: that Contestant is in good health and is able to compete in the scheduled Contest; that Contestant is not under suspension by any athletic commission; that Contestant has not suffered a knockout within the past 30 days; that Contestant has not suffered three knockouts within the preceding twelve month period; and that the Contestant's last match was on the _____ day of _____, 20___, in the city of _____, scheduled for _____ rounds, and that the result was _____ (the "Last Match"). Contestant agrees not to participate in another match between the Last Match and the Contest scheduled under this Agreement. The term "knockout" as used herein included technical knockouts.

3. Contestant agrees to be present at the weigh-in ceremony at the time dictated by the Commission, and agrees to submit to any required pre-fight physical examination and drug testing. If the Contestant is late to, or fails to show at, the weigh-in ceremony, fails to submit to a required pre-fight

physical or drug test, or fails to make the agreed-upon weight, the Contestant is subject to discipline, including, but not limited to, a breach of contract violation, disqualification, forfeiture of purse moneys, a civil penalty, suspension or revocation of license, or a combination of any of the above.

4. The Contest is to be conducted under the rules and procedures of the Commission, in accordance with applicable Arizona laws.

5. Promoter shall provide insurance for Contestant for medical, surgical and hospital care for injuries sustained in the ring in the amount of \$20,000 with a \$25 deductible payable to the Contestant as beneficiary, and for life insurance in the amount of \$50,000 in case of accidental death resulting from injuries in the ring payable to the Contestant's designated beneficiary. Contestant's designated beneficiary is _____, whose relationship to Contestant is _____. Certificates for these policies shall be attached.

6. This, and any addendum attached hereto, represents the entire agreement for the parties. Failure to disclose the entire agreement between both parties may be grounds for disciplinary action.
